1 PERSONAL DATA

In principle, the protection of your personal data takes top priority for Kluman & Balter and Brenntag. This is why we do not collect any personal data through our website without your consent. You alone decide whether you want to give us this data or not, for example during registration, in a survey, etc.

We generally use your personal data to answer your enquiry, process your order or give you access to special information or offers.
